The scope and purpose of the **Historic Staunton River Foundation** is to promote, develop, and preserve: the 1864 Battlefield at the Staunton River; the Staunton River Bridge; Staunton River Battlefield State Park; the Staunton River historical areas and environs; Roanoke Station; Mulberry Hill Plantation, the ancestral home of the Carrington family; the Randy K. Wade Archaeological Site and any future archaeological discoveries in the area of the Staunton River; and the Sappony Indian Nation.

Friends of the Overseer's Quarters Group Formed

The Historic Staunton River Foundation, Inc. is pleased to announce that Commonwealth Architects from Richmond, Virginia was contracted by the Staunton River Battlefield State Park and the Virginia Department of Conservation and Recreation to assemble an "architectural and engineering team to document, analyze, and propose rehabilitation recommendations for the Overseer's Quarters, an important component of" Mulberry Hill Plantation in Randolph, Virginia. The Overseer's Quarters, located directly behind the main house, is in great dilapidation and in dire need of repair. Nathaniel David Dickerson and wife, Nancy Green Moses, with their family, occupied the small structure between 1845 and 1850. It is the hope of the Historic Foundation to aid in the grant-writing process to help secure the monies needed to rehabilitate the structure. The Descendants of Nathaniel David Dickerson have also displayed their support for this project through a recent family reunion. Their upcoming family newsletter efforts to save the Overseer's Quarters.



Following their recent visit, representatives from Commonwealth Architects submitted a report with written recommendations and measured drawings; this assessment report will aid in the guidance of the work needed, as well as estimate the associated costs. The report is in two parts: Part I "includes existing conditions analysis for exterior and interior, and existing conditions architectural drawings for exterior and interior," and Part II "includes both general and specific recommendations for rehabilitation for exterior and interior, cost estimates by proposed repair, and a summary table of the cost estimates." The report further states, "overall, the building stands in fair condition. The quality and care of its initial construction has resulted in a building that has withstood years of use. Unfortunately, high levels of moisture and insect damage are severely impacting the building." Several standards from the Secretary of Interior will be enforced that will ensure that the property will "be used for its historic purpose...in a new use that requires minimal change to the defining characteristics of the building," and the "historic character of the property shall be retained and preserved." Every effort will be made to ensure and maintain the building's historical, architectural, and cultural value.

The rehabilitation process is inclusive of every element of the building from the ground-up. The procedures listed in the report include the rehabilitation of the masonry (open mortar joints, spalls, flaking, scaling, crumbling, cracking, oxide jacking, and repair); the plaster (identification, patching, replacement, cracks, delaminated coats, missing plaster, and repair); the metal roofing (evidence indicates original roof of wood shingles; install a historically appropriate standing seam tern-coated metal roof similar to existing one, install gutters and downspouts); the wood (treatment of unpainted surface, removal of individual units, pretreatment and patching compound, component replacements removal of deteriorated paint, surface preparation, painting, and repair); the windows (replace glazing and repair); and the site (proper landscaping, drainage, and traffic sealant). Cost estimates are available for each location and recommendation, and each are given a priority level of 1 to 4 (1 for immediate attention, 2 for conditions that need to be addressed within a year, 3 for low priority that does not threaten the integrity of the building, and 4 for materials or features that require routine inspection and require action for many years). The assessment report estimates the project total at \$80,000. It is the hope that a grant can be obtained to secure these funds. However, a majority of grants require the applicant to hold a percentage (ranging from 10% to 20% percent) of the project total. In this scenario, the Foundation would need to have between \$8,000 and \$16,000 in matching funds in order to meet the requirements set forth in the grant application.

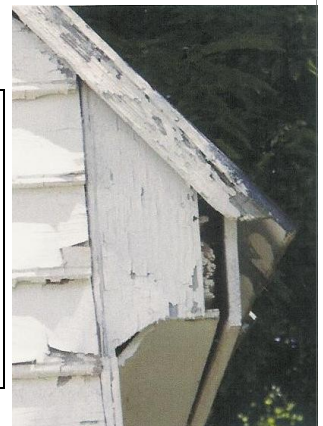
The Historic Staunton River Foundation, Inc. stands behind the commitment in repairing the Overseer's Quarters. Just as Captain Benjamin Farinholt made an urgent plea to the citizens of the surrounding counties to defend the Staunton River Battlefield from the 1864 invaders, so too, does the Foundation make a plea to the public in financially supporting the rehabilitation of the Overseer's Quarters. As a 501(c) 3, tax-exempt organization, the Foundation will act as the "fiscal agent" for this project. An account has been set-up for the strict financial benefit for the "Friends of the Overseer's Quarters of Mulberry Hill Plantation."

Founded in 1995, the Historic Staunton River Foundation, Incorporated, a tax-exempt, private organization under 501(c)3 of the Internal Revenue Code, was formed to act as the "citizen-support organization" for the Staunton River Battlefield State Park. Its mission is to "promote, preserve, and develop the 1864 Battlefield at the Staunton River Bridge, the Staunton River Battlefield State Park, the Staunton River and its historical areas, the Wade Archaeological Site, and Mulberry Hill Plantation. The Foundation shall also collect artifacts and historical memorabilia for display and work to preserve the integrity of the Staunton River environs and archeological sites. The Foundation will provide historical, environmental, wildlife, and wetlands education, as well as assist in developing programs and events for the general public." The Foundation is governed by a seventeen member Board of Trustees and its at-large membership. Membership is available for \$15 and entitles the bearer to a 10% discount in the Clover Visitor Center Gift-shop; a subscription to The Sentinel, the Foundation's newsletter; and invitations to special lectures and events. Golf Cart Donated to Foundation

The Foundation has greatly needed a mobile and versatile personal-utility transport. The Park already is in possession of a bus, but something smaller, that is able to squeeze along the trails and scurry across the fields was needed. For several years, different Trustees and Foundation members would bring attention to small vehicles (either electric or gas powered) that would serve the mobile needs of the Foundation during different Park events and activities.



Finally, this past summer, Trustee Shane Newcombe discovered "Pappy's Golf Carts" in North Carolina (just over the State line). This golf cart shop was then brought to the attention of Trustee Kory R. Snead. Within a couple of weeks, Snead, with four volunteers in stead, headed to North Carolina with a trailer in pursuit and the Foundation purchased a Club Car golf cart. The Club Car, painted in a Harley-Davidson, blue-color scheme, can comfortably seat 3 people, while carrying a full load of miscellaneous items. The cart arrived at the cusp of the annual Haunted Harvest Hayride, where it was properly christened for a Foundation event!

That night, the cart was used to transport actors and volunteers all throughout the trail and fields to scare and entertain the visitors during the Haunted Hayride! In addition, it carried the load of supplies, props, and items needed to carryout the event. The next day it was used as a "clean-up vehicle," where its supported the weight and load of a mock coffin filled with haunts and spooky decorations. Several Foundation volunteers, members, and trustees commented, "we do not know what we did [before] without this little golf cart! At the November Board meeting, Mr. Snead announced his intentions of donating his half of the purchase price of the golf cart to the Foundation!

2009 Visitation Reaches Record High

(RICHMOND) Despite a struggling economy, Virginia State Parks set a new attendance record in 2009, with 7,534,960 visitors, a four percent increase over 2008. In 2008, more than 7.2 million people visited Virginia State Parks, down slightly from the previous record high of 7.4 million visitors in 2007. "Millions of people continue to look to Virginia State Parks as a vacation destination in these uncertain economic times," said Virginia Department of Conservation and Recreation State Parks Director Joe Elton. "These past three years have seen the highest state park attendance in our 74 year history because people continue to see the value and



benefit of visiting our parks. Year after year, generation after generation, visitors return to our parks to camp, hike, swim, fish, bike, or simply relax in a cabin or family lodge." In 2009, 253,116 visitors stayed in a state park cabin or lodge, and another 646,506 visitors spent the night in a state park campground. While Virginia State Parks are a primary vacation destination for millions of people from around the country, state parks also are an economic stimulant to local economies. The estimated economic impact of Virginia State Parks last year was \$175 million. The estimated economic impact in 2008 was \$168 million, and in 2007, with the slightly higher attendance, the estimated economic impact was \$171 million. "The contribution of Virginia State Parks to state and local tourism is significant and can be especially important in the current economic climate," Elton stated. "Overnight guests in 26 of Virginia's 35 state parks contribute to local economies, as well as to the state economy. Last year, more than 899,000 people stayed in cabins, family lodges or campsites located across Virginia," he said. Continued on page 7.

A Job Well Done !

Congratulations to all of our volunteers on a job well done. In 2009, 1392 volunteer hours were recorded for the Staunton River Bridge State Park. Tiffany Snow, Program Support Technician for the park, also reports that in 2008 we had 1,385 volunteer hours, but in 2007, we had 2,413. She says "I would like to beat the 2007 record in 2010. If we all work together and strive to meet this goal it would be great for the park." To recognize our faithful friends who support the park by giving of their time, they are listed below.



Gaston Rouse, the State Park Director of Volunteer Services, sent out an email in which he made the following statement: "The last three years has seen a 70 % increase in volunteer hours in State Parks. Total volunteer hrs for CY 09 was 235,546 Hrs, which translate to 4.8 Million dollars about 1/3 of Parks' operational budget. The hours also equates to 147 individuals working for Parks, about 1/4 of authorized personnel. To use a common phrase "You did good" and you are making a difference!

"In addition to the park accommodation fees paid to the state, most of those visitors bought food or ice nearby, visited local attractions or restaurants, and filled up the gas tank before driving home. Because our parks are primarily in rural areas, the economic impact is especially important in rural counties throughout Virginia, including Southside, Shenandoah Valley, central Virginia and the Eastern Shore," Elton said. "Virginia's urban areas, such as Virginia Beach, Northern Virginia and Richmond, also benefit from visitors to our parks in those areas. The increase in attendance is an indication that state parks remain an affordable and attractive choice for visits, vacations and relaxing recreational opportunities. Last year, Virginia State Parks won nearly 90 awards from private and public groups, and the record high attendance is just one more indicator that our state parks are among the best in the nation," Elton said.

Virginia State Parks are managed by the Virginia Department of Conservation and Recreation, and offer dozens of festivals and concerts and thousands of educational programs across the state.

"Virginia State Parks allow the people of Virginia the opportunity to protect our natural resources and cultural treasures, while providing affordable and unique recreational opportunities," Elton said. "We help connect children and families to nature, great outdoor recreation opportunities and a healthy lifestyle. In addition to a new attendance record, 2009 also brought a record number of volunteers. More than 235,000 hours of service were given by citizens helping park staff. Some help collect fees, some give nature and history programs, others help with maintenance projects," said Elton.

There are opportunities for anyone to have fun while helping make our state park system even better. 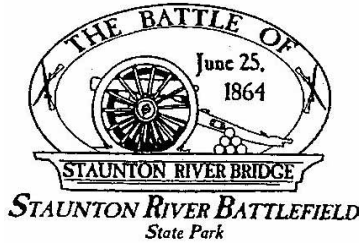
